

## A. SCHOOL FEES:

The approved school fees for 2020 are R 11,200.00 per learner.

I, the undersigned parent / guardian / accountable person hereby acknowledge, confirm and undertake as follow:

1. That the school is a State-supported school and that I undertake to pay all school fees, as determined by the Governing body in terms of the Schools Act 84 of 1996, on time as they may become due and payable.
2. That I will inform the school timeously and will make alternative arrangements should I encounter difficulty in making payments of the school fees.
3. That all school fees are payable strictly in advance on the 1<sup>st</sup> day of every school year.
4. That, should I fail to make payments in terms of this undertaking or any other agreement I entered into with the School on the due date, the School will be entitled to immediately claim all arrear amounts from me, together with arrear interest (*a tempora morae*) until date of final payment
5. That the School will be entitled to take legal action for payment of my/our outstanding account and that I will pay all legal costs incurred on a scale as between attorney and client, including collection commission, tracing fees, sheriff's costs and all other reasonable expenses.
6. That a certificate, signed and issued by the Financial member of the School's Governing Body, whose appointment need not be proved, shall be sufficient (*prima facie*) proof of the amounts due by me for purposes of an application for provisional sentence or summary judgment.
7. That the addresses as set out in this form are chosen by me/us as address where notices or pleadings may be served on me/us, irrespective if it is served personally or not, which address is also known as our chosen *domicilium citandi et executandi*.
8. That the information as disclosed in this form is true and correct that I/we, the parents will inform the school in writing, within seven days, of any change in residential or work address or should the learner change school.
9. I/We confirm that we have the right to apply for financial aid (for a reduction or exemption) of school fees, for which purpose a complete written application must be submitted. Until the application has been approved (either for reduction or exemption) I will remain liable for the school fees. I furthermore confirm that I will remain liable for all arrear school fees.
10. I/We confirm and guarantee that the above information is correct and binding on me/us and the person who is liable for payment of this account.
