



Dear Parent/Guardian

A word of thanks to the parents who attended our annual budget meeting, and enlightened themselves of the financial position of our school. A resolution was adopted for compulsory school fees for 2020.

1. SCHOOL FEES 2020

The budget was presented and unanimously accepted by the meeting. The school fees for the year 2020 would be set at R11 220.00 per learner.

2. Means of payment

We would once again like to emphasize that the following methods of payment will be accepted:

2.1 One amount

As a lump sum of R11 220.00 paid before 9 February 2020, which entitles you to a discount of R300.00 per child. (Amount therefore payable is R10 920.00)

2.2. Two payments

In two payments: R5 610.00 paid before 9 February 2020 (Amount payable R5 510.00)
R5 610.00 paid before 20 July 2020 (Amount payable R5 510.00)
(A discount of R100.00 per payment)

2.3 Debit order

R11 220.00 payable in 11 payments of R1 020.00 (Debit order only).

A new debit order form is attached please indicate your preference. Please remember to complete the front and back of the debit order form and return to school by 7 November 2019.

The **first** payment will be on the following 3 dates: **25 January, 1 February and 15 February 2020.**

The school reserves the right to allocate the payment of funds received to any outstanding amount owed by the person liable for school fees, unless otherwise indicated.

Please note that in terms of the South African Schools Act, the paying of school fees is compulsory.

We currently receive only R16.00 per pupil per month from the Department, and therefore rely heavily on our parents to pay their school fees. The school cannot function successfully without the **involvement and financial support of the parent body.**

2.4 Exemptions

- Please note that you are **compelled** to pay school fees, in terms of Section 39 of the South African Schools Act No. 84 1996.
- Non payment of school fees will be handed over to Attorneys and Conveyancers.
- The Governing Body of a public school has the right, according to Section 40 of the South African Schools Act No. 84 1996, to enforce payment of school fees and may thereby obtain such fees through legal action

Parents, who feel that they qualify for:

- Complete;
- Partial;
- Conditional exemption from the payment of school fees and wish to enquire about the details of exemption regulations, must **PERSONALLY** contact the office to view and collect the necessary application forms from the financial secretary, and to meet with Mrs B Lotz and Mrs Burger regarding completion of the form.
