SCHOOL FEES - 2020

The 2020 fees were agreed at the Annual General Meeting of 24 October 2019. We wish to advise that school fees per learner for the 2020 school year will be R26450 for Grade 1-3 and R28400 for Grade R. School fees are payable in **10 monthly instalments** of R2645.00 (Grade R- R2840.00) the first payment to be made by 31 January 2020.

The following payment options are available:

- (a) In cash to the school. **A cash deposit fee may be charged to the parent/guardians account (Amounts over R500 must be deposited directly into the School's bank account and email proof of payment).**

- (b) EFT payments.
- (c) By debit order, in which event parents are requested to complete the annexed debit order form.

DISCOUNTS

Parents who settle their accounts in full, on or before 30 December 2019, **and pay directly into the school's bank account**, will be entitled to a discount of R1200 (Grade R – R1200) per learner. (Email proof of payment to the school).

Parents who settle their accounts in full by 30 January 2020 will be entitled to a discount of R1000 per learner. (Email proof of payment to the school). **Cash deposit fees will be charged to the Parent/guardian**

PROCESS FOR APPLICATION FOR EXEMPTION/PARTIAL EXEMPTION OF SCHOOL FEES

Written application for exemption/partial exemption of school fees is to be submitted before 31 January 2020. This application form is obtainable from the office. Should the application not be successful, an appeal can be made to the Governing Body and Gauteng Department of Education via the Governing Body.
