

D. SCHEDULE OF SCHOOL FEES FOR 2020

Please note that Port Alfred High School is a fee-paying school as per Government Gazette, November 1996, Act No. 84, 4.1:

“The governing body of a public school may by process of law enforce the payment of school fees by parents who are liable to pay.”

Bursaries are unfortunately limited and largely unavailable.

The Schedule of School Fees for 2021 is not yet finalized. The 2020 Schedule of School Fees is as follows:

If school fees are paid in full on or before 31 December a discount will be deducted from your compulsory annual school fees. Please find out more about this from the Bursar’s office.

A sum of R2000 is to accompany this admission form. This amount will be deducted from your 2021 compulsory annual school fee account. ***This R2000 fee is compulsory to ensure that your child’s place in Port Alfred High School for 2020 is reserved and is payable once your child has been accepted.***

TERMS AND CONDITIONS OF PAYMENT OF SCHOOL FEES

In terms of the provisions of the Government Gazette, November 1996, Act No. 84, 4.1. “The governing body of a public school may by process of law enforce the payment of school fees by parents who are liable to pay.”

PREAMBLE

- 1.1 School fees are determined in consultation with the parents of this school at the Annual General Meeting.
- 1.2. School fees are payable in advance on or before 31 January of the academic year. The Governing Body is prepared to accept payment of school fees over 10 (ten) months from January to October in accordance with this agreement. No indulgence or latitude will be construed as a waiver or novation of any rights the Governing Body may have.
- 1.3 A deposit of R2000 for the following year will be payable on or before 30 November. ***This R2000 fee is required to ensure that your child’s place in Port Alfred High School for 2020 is reserved.***

DEFAULT

- 2.1 **Should you fail to make payments in accordance with this agreement, the balance of the year’s school fees immediately become due and payable.**
- 2.2 Should you fail to make payments in accordance with this agreement, the Governing Body may institute legal action against you for collection of the full amount of the compulsory annual school fees, in which event you would be liable for costs on the scale as between attorney and client, including collection commission; furthermore your credit rating may be blacklisted;
- 2.3 A certificate signed by the Headmaster or the Bursar shall be prima facie proof of any amount outstanding in terms of this agreement.
