A 5% sibling rebate will be applicable to families with 2 or more children enrolled at Tyger Valley School.

REGISTRATION AND ENROLMENT FEES FOR NEW PUPILS

A R750 application fee is payable upon submission of the online admission form. **No application can be processed until all the relevant documentation has been provided:**

- A copy of the pupil's ID document or birth certificate
- A copy of each parent's ID document
- A copy of the pupil's latest school report, where applicable

FOR NEW PUPILS

A non-refundable enrolment fee is payable as follows:

- Grade 0000: **R1 500**
- For the first child (Grade 000 – 9) – **R15 000** payable when the child is accepted into the School by the principal.
- For the second child – **R7 500** payable when the child is accepted into the School by the principal.
- For three or more children – No enrolment fee is payable unless the child is starting in Gr0000.
- Grade 10 -12 – **R7 500** payable when the child is accepted into the School by the principal.

Please note: If payment is not made by the due date the pupil forfeits his/her place. A child may only qualify for one of the abovementioned discounts.

EARLY SETTLEMENT

If annual tuition fees are settled in full by the first Friday of the first School term, that is, the **15th January 2020**, a 5% reduction on the fee is applicable (see table above).

Should the annual upfront plan be selected by the fee payer, but the full annual amount is not paid by the 15th January 2020, will result in the account being automatically defaulted to the 12-monthly plan with the monthly instalment becoming due immediately. A penalty of R4 000 will be charged.

OUTSTANDING FEES

1. Outstanding fees for each month will be charged interest at prime plus 5%.
2. If fees are in arrears the School reserves the right to take the necessary steps as per the conditions of the Parent Contract.

PAYMENTS

The School fee payments may be made annually or monthly in advance on or before the 1st of every month. Debit orders are compulsory to streamline monthly fee collections. The School's Banking Account details are:
